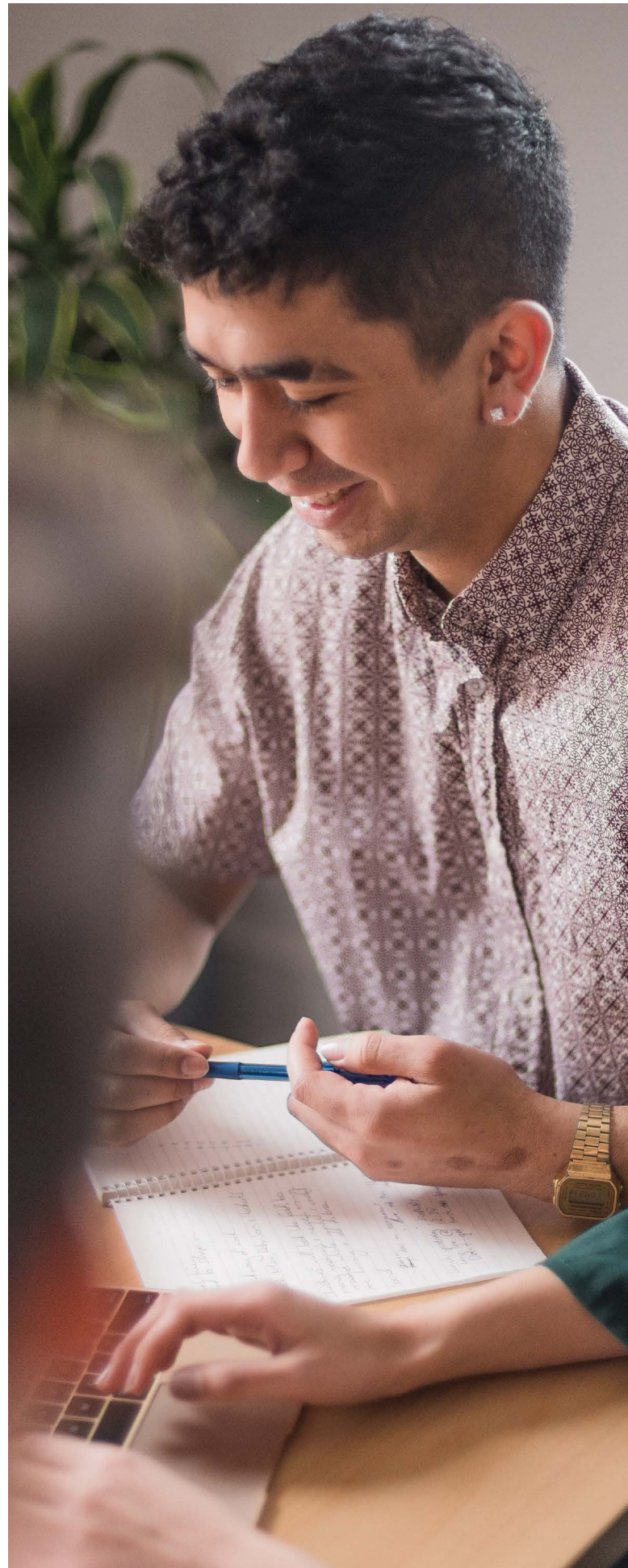
OUTSTANDING



Te Herenga Waka—Victoria University of Wellington has been awarded an overall five-stars-plus rating in the QS Stars university rating system, one of only 17 universities worldwide to do so. The University gained a total

score of 966 out of a possible 1,000 points across eight audited categories, including maximum points for the employability and inclusiveness categories. Maximum points were awarded for 25 of the more than 30 indicators, including overall student satisfaction; further study; graduate employment rate; international diversity, support, and collaborations; academic reputation; satisfaction with teaching; campus facilities; accreditations; art and cultural investment and facilities; disabled access; scholarships and bursaries; low-income outreach; and student cohort diversity.

ACCELERATE YOUR CAREER

Our professional programmes combine academic knowledge and practical and professional experience, with a focus on career progression. You'll develop practical skills that you can immediately put to use in your professional life and build a bank of knowledge and tools that will maximise your career potential. As well as subject-specific knowledge, you will develop capabilities you can transfer to everyday life, such as negotiation, presentation, and problem solving.

Over the course of your programme, you'll build a strong network of fellow students, leading academics, and industry leaders through regular group work, internship opportunities, and consultancy projects.

STUDY THAT FITS AROUND YOU

All our programmes have been designed with the flexibility to fit around your work and life commitments and goals.

Most programmes can be completed in just over a year of full-time study for those looking for an intensive pathway to launch their career and for international students looking to travel to New Zealand. However, many of our students will choose to study part time, taking just one or two courses per trimester, as a way to balance their studies with their other commitments. This ensures pursuing your career goals doesn't have to mean sacrificing the things that are most important to you. The total workload for each 15-point course is about 10–12 hours per week, including contact time on the weeks you have lectures.

RESEARCH-FOCUSED PROGRAMMES

BACHELOR OF COMMERCE WITH HONOURS AND MASTER OF COMMERCE

Gain thorough training in independent research and explore a topic you are passionate about with the Bachelor of Commerce with Honours (BCom(Hons)) and the Master of Commerce (MCom). Through these programmes, you will be exposed to a diverse range of methods of data collection, analysis, and interpretation, including surveys and focus groups, experimental research, critical theory, statistics, complexity and network science, design thinking, and Indigenous methodologies.

You will receive an unparalleled classroom experience with one-on-one mentoring and supervision by leading academics, small highly interactive classes, and frequent presentations. You will gain advanced professional skills in analysis, synthesis, and communication, and become part of a community of students who have a profound and critical voice that is heard across all sectors of society.

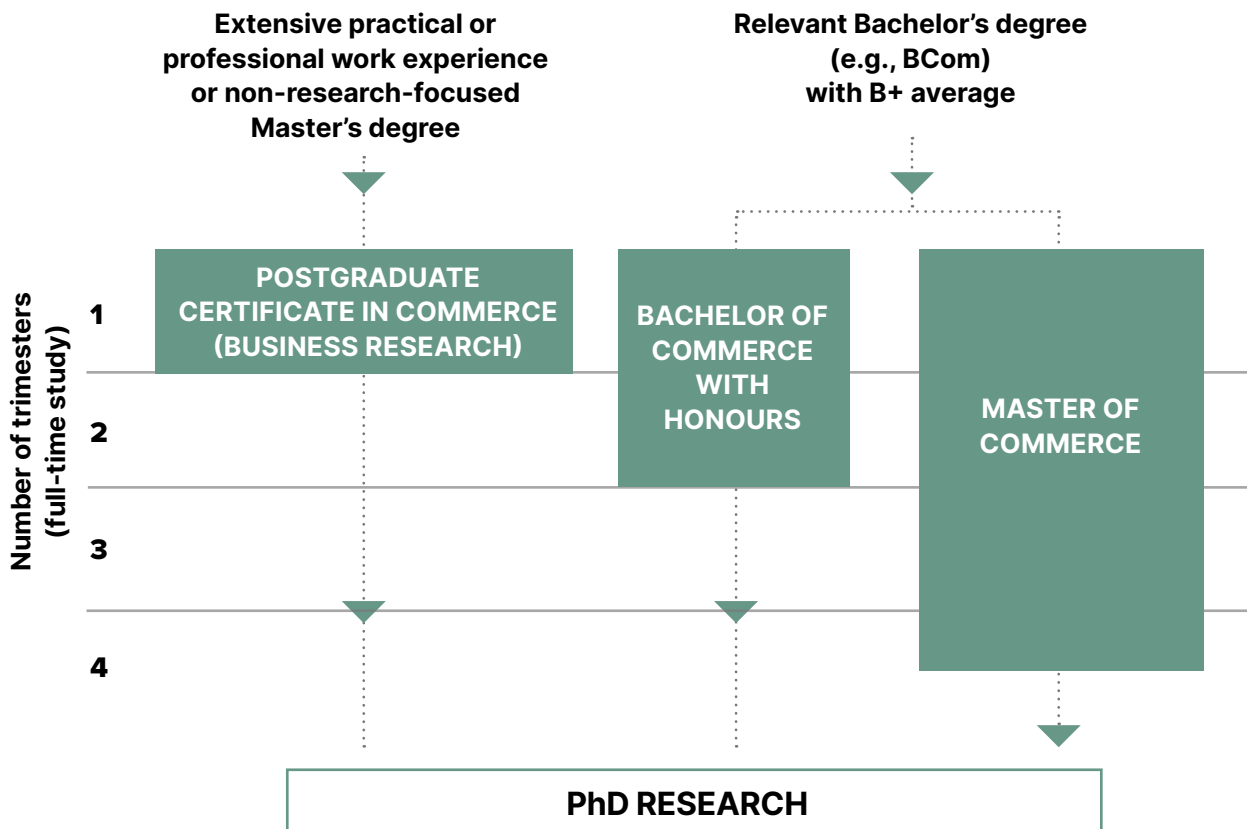

SPECIALIST KNOWLEDGE AND INTERDISCIPLINARY THINKING

Depending on your undergraduate major and your course of study at Master's level, you can be awarded a BCom(Hons) or MCom with a specialisation in one of the following areas:

- Accounting
- Economics
- Finance
- Governing for the Future
- Human Resource Management and Employment Relations
- Information Systems
- International Business
- Management
- Marketing.



RESEARCH YOUR PASSION

It is important that you bring your own experiences and interests into your postgraduate research and work on topics that matter to you. Some examples of the topics our students and staff are researching include:

- What can we learn about sustainable management from Māori businesses?
- How can we make bad bosses less common in our workplaces?
- How can we make Aotearoa a better place to work for marginalised communities?
- How can computer-based modelling enhance our healthcare system?
- How do computer algorithms influence how we live and work?
- What role does branding play in driving consumer behaviour?
- What mechanisms underpin the spread of misinformation online?
- Can humour be used in social marketing to encourage young males to stop their friends drink-driving?

PHD STUDY

A Doctor of Philosophy (PhD) degree represents the highest academic achievement. It involves original and sustained research under academic supervision, and demands considerable self-discipline and dedication. Completing a PhD is a significant undertaking and takes at least three years of full-time study.

Prospective students with a non-research-based Master's degree, or extensive practical or professional work experience, may be admitted to the Postgraduate Certificate in Commerce with a specialisation in Research (PGCertCom(Rsch)), which can be used as a stepping stone into the full PhD programme.

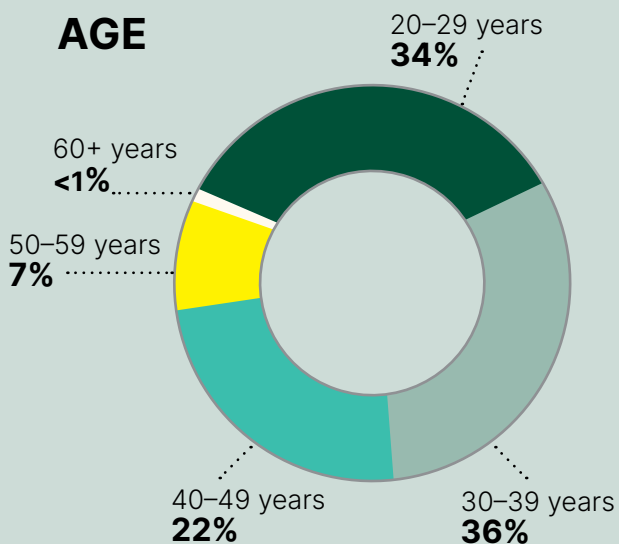

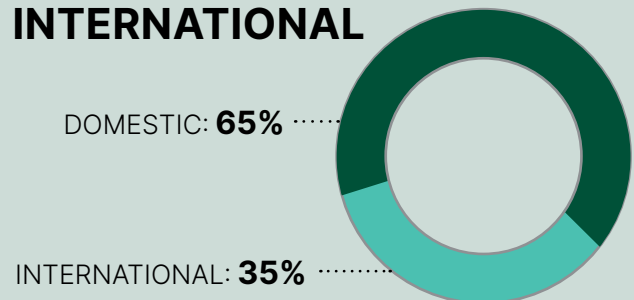

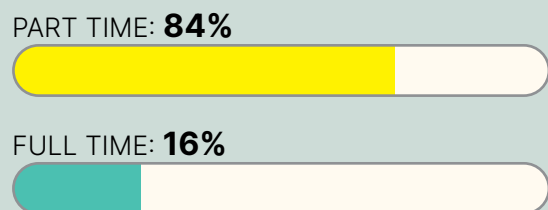

MANAGING YOUR STUDY

Furthering your education can be a daunting prospect, especially if you're balancing work commitments or it's been a while since you studied. The capability boost you will get from further study is also a big investment to make, both financially and time-wise. At the Wellington School of Business and Government, we offer different ways for students to make postgraduate study more manageable, including flexible, shorter study options, scholarships, and resources to help ask your employer for support.

STAIRCASING WITH CERTIFICATE AND DIPLOMA OPTIONS

If you're not ready to enrol in a full Master's degree, then a postgraduate certificate or postgraduate diploma could be the right choice. You will get to experience some of the courses included in the full Master's degree and decide if that programme is right for you. Certificates and diplomas can also be used to 'staircase' into a full Master's degree. With the staircasing approach, you have the option to credit shorter qualifications such as a postgraduate certificate or diploma towards a full Master's degree if you decide to continue studying.

BACHELOR OF COMMERCE WITH HONOURS

RESEARCH

The Bachelor of Commerce with Honours (BCom(Hons)) is a postgraduate research programme that allows you to add the distinction of a short independent research project to your undergraduate qualification. You'll gain valuable research skills under the supervision and mentorship of one of the world-class scholars at our faculty. Studied full time, it can be finished within two trimesters and allows entry into the PhD programme at universities in New Zealand and other countries that have accredited Honours degrees.

The BCom(Hons) differentiates you from other professionals as an expert with a focus on developing an evidence base for decisions and recommendations. Your research will conclude by writing a 10,000-word research report, and you will have the opportunity to present your work to a variety of stakeholders at our annual postgraduate showcase.

Actuarial Science is a fully accredited programme with the Actuaries Institute of Australia. Students seeking to become an actuary may be granted exemptions from some institute foundation- and actuary-level subjects.

- Library and Information Association New Zealand Aotearoa, for those with a specialisation in Library Science (recognised by the American Library Association).

The Master of Professional Accounting meets the academic requirements for certification from the Association of Chartered Certified Accountants, CA ANZ, the Chartered Institute of Management Accountants, and CPA Australia. If you complete the CA pathway you will also meet the technical requirements for certification from CA ANZ.

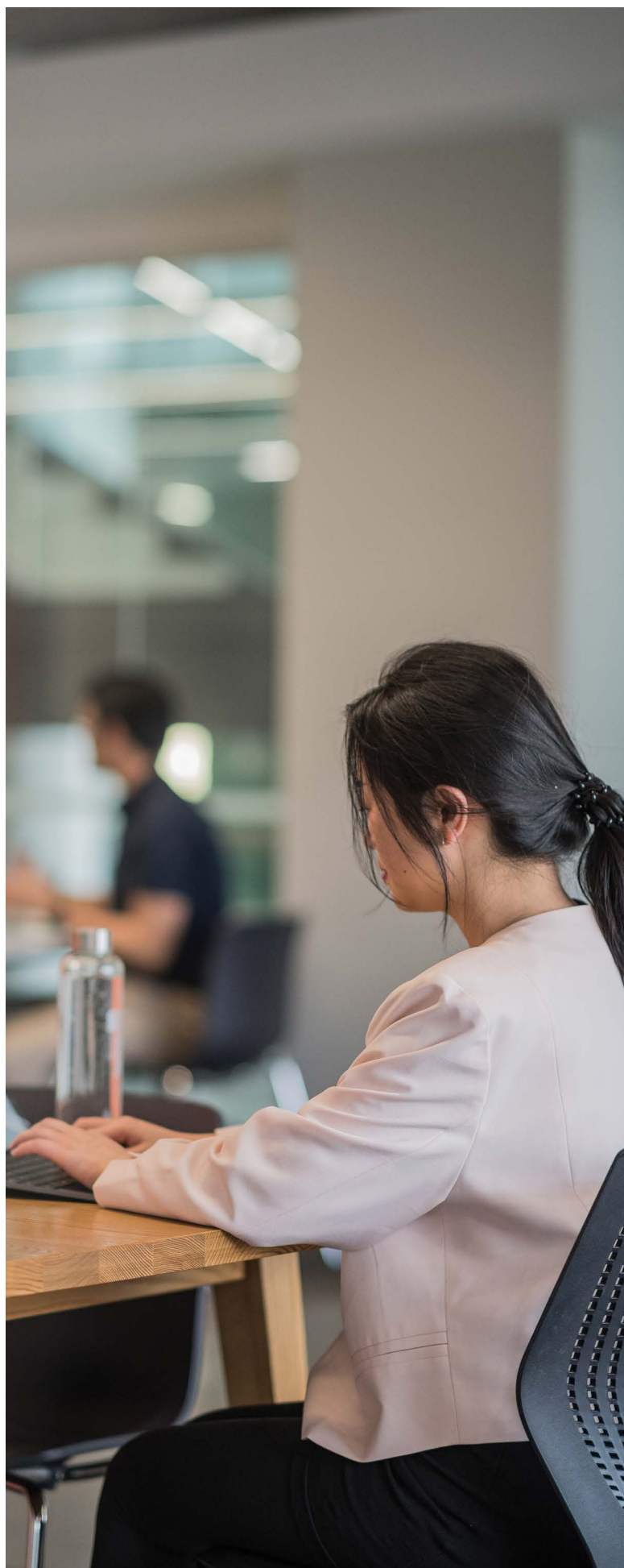
