## REPORT FROM THE VICE-CHANCELLOR

Received:

a report from the Vice-Chancellor, Professor Nic Smith, dated 22 July 2024 (document VUWC 24/79).

Noted:

- 1 that the report was taken as read.
- that the Strategy Refresh work is close to completion with staff, student, and other stakeholder groups having the chance to provide feedback. The refreshed strategy will cover the period 2025-2027 and is aimed at three focus areas creating time for staff and clarity of their work, financial sustainability, and connecting to our ecosystems. The Council will discuss a close to final version in the confidential session of the meeting, aiming to approve the Strategy in public at the 9 September Council meeting.
- 3 that a Process Improvement Suggestion inbox has been set up in the Vice-Chancellor's office in response to feedback in the YourVoice survey. To date 20 emails have been received covering a range of areas, some of which are quite technical. Staff will be kept informed as issues are worked on and resolved.
- that the University Advisory Group (UAG), chaired by Sir Peter Gluckman, and on which Victoria's Chancellor sits, will visit on 12 August. The visit will provide members of the UAG with an understanding of the University's research capabilities. It will also provide an opportunity to hear from students, Māori and Pasifika leadership, and academic leaders and management staff, on their views and suggestions for the sector.
- that the programme for the day is being finalised by Mr Reece Moors, and Council members will be invited to part of the day. The Chancellor noted that he will not be part of this visit but has been assigned to visit Waikato and Massey Universities in his UAG capacity.
- that new students in University Halls will start one week earlier than prior years to assist them to engage with University life, including an introduction to academic expectations, opportunities to experience activities across the city, and to build cohorts of social connection which is known to be a challenge for some students.
- that the judgement in the Siouxsie Wiles case was discussed. Management will take this as an opportunity to start a conversation on what the University can learn from what has happened and further enhance support for our own staff. The critical need for Academic staff to operate as critic and conscience in society is key to the role of Universities, and this an important issue for our university community.
- that the Public Service Scholarship had resulted in 40 fully enrolled students who had met the criteria, along with a significant amount of good will from this initiative.
- that the Women in Leadership Programme, Whaipua, has been well received with 54 applications for 20 places. Unsuccessful applicants have been directed to other leadership and mentoring opportunities.
- that Council commended the Vice-Chancellor, and Te Hiwa, for what has become an ongoing sequence of good news and positive initiatives.
