(II) Aims, Objectives, Content

GREE 316 is a course in reading ancient Greek poetry and prose. Building on GREE 315, its aim is to refine students' understanding of ancient Greek and to introduce them to the study of Greek poetry and prose by close reading of selected texts. The first six weeks (9 July-17 August) will be devoted to reading Thucydides *History* 2, focusing particularly on Pericles' funeral oration. In the second six weeks (3 September-12 October), we will read Sophocles *Oedipus the King*.

Students who pass this course should:

(1) have attained competence in the reading of Thucydides' and Sophocles' Greek;

(2) be able to translate passages of unseen Greek with fluency;

(3) have an understanding of the conventions of the funeral oration, the peculiarities of Thucydides' rendition of it, and the place of this funeral oration within the overall context of the *History*;

(4) have a good working knowledge of the meters of Sophocles *Oedipus the King* and understand the major problems and themes of the play as well as the historical context of its performance.

Assessment and objectives: The assessment is designed to test students' ability to translate and comment on the language and subject matter of the set texts, to scan lyric and spoken verse, to translate passages of unseen Greek, and to analyze the text based upon knowledge of diction, syntax, imagery, argument, and conventions of the genre under consideration.

IV. Workload, Requirements, Penalties

Workload: It is recommended that students spend at least 18 hours per week (including class hours) on this course. It is essential to keep revising basic elements of the language at every opportunity.

Mandatory requirements: in order to be eligible for a passing grade in this course, students must submit text analyses on passages from Thucydides Book II and Sophocles *Oedipus the King* and sit the final exam.

Attendance: There are no mandatory attendance requirements. However, students should attend at least 2/3 of the classes in this course.

Extensions/Penalties: extensions must be requested in advance of the due-date and supported by suitable evidence (e.g. medical certificate). Work submitted late without an approved extension may be subject to a penalty 5 marks/day late.
