Prescription

This course examines textual, theological and practical resources that religious believers use to inform their engagement with political and public issues. Contemporary issues are evaluated against the backdrop of historical debates concerning interactions of religion and politics. Case studies exemplify approaches to political thought and activism used within different traditions.

Course learning objectives (CLOs)

Students who pass this course should be able to:

- 1. Identify and analyse one issue in which religion and politics intersect
- 2. Identify and analyse important religious ideas and dynamics relevant to the issue under consideration
- 3. Demonstrate the ability to construct a coherent, well-written, evidence-based argument with respect to an issue in religion and politics.
- 4. Demonstrate the ability to verbally communicate the findings and significance of research undertaken with respect to an issue in religion and politics.

Teaching format

This course is delivered through regular seminars. The seminar programme may be varied from time to time. As much notice as possible will be given when changes occur and, a revised programme will be issued.

Mandatory course requirements

In addition to achieving an overall pass mark of 50%, students must:

- 1. Submit one essay proposal and annotated bibliography
- 2. Submit one essay
- 3. Give one seminar presentation

Workload

The total expected workload for this course is 300 hours spread evenly over the trimester.

Assessment

Assessment for the whole course is by means of two written assignments, and one oral presentation.

- One research essay proposal and annotated bibliography of 2,500 words, on a topic to be negotiated with Dr Troughton, worth 20% of the total course grade: to be submitted by Friday 11 April.
 - a. Students must notify Dr Troughton of their intended topic by **Monday 17 March**.
- 2. One **research essay** of a maximum of 6,000 words, worth **70%** of the total course grade; to be submitted by **Friday 27 June**.
 - a. Students must submit full drafts of their essays by
- 3. A 30-minute in-class **seminar**, based on the student's research essay, worth **10%** of the total course grade. Times to be arranged in class, prior to 16th May 2014

Specific guidelines for each assessment will be distributed in class.

Rationale for assessment

The essay allows students to apply their analytical skills to information retrieved through library research on a set topic. Essays demonstrate the students' level of proficiency in finding, understanding, and using sources. They develop the skills of critical reading, analysis and organizing material necessary for continued study in the area. The process also gives the opportunity to develop more in-depth knowledge of an area covered and the skills of critical analysis. The seminar presentations allow students to develop their skills in small group teaching and discussion.

Submission and return of work

Essays are to be submitted by email to Dr Troughton AND to the essay box outside the Programme Office, HU 318. Marked work shall be returned by Dr Troughton at seminars. Feedback shall be given regularly throughout the trimester.

Set texts

There is no set textbook for both parts of the course. Readings shall be available via Blackboard or copies may be provided by the Religious Studies Programme at a student's request at cost.
